- Military Simulation Airsoft game 09/04/2024 in Mitsero, Nicosia.
- Seminar on the snakes of Cyprus 29/04/2023 at the Kofinou Cultural Center, Larnaca.
- Meeting in the House of Representatives on the issue of the permanence of Airsoft in Cyprus, 01/06/2023, Nicosia.

- Meeting at the Ministry of Justice and Public Affairs Class for matters concerning the law of Legalization of Airsoft in Cyprus, 12/09/2023, Nicosia
- 1<sup>th</sup> General and election meeting of the union, 08/10/2023, Aradippou High School "Tassos Mitsopoulos", Larnaca

### 3. Decisions

a. Election of the board of administrators through anonymous voting of the members of the union. (Number of candidates 9 (Argyris Argyrou, Kondi Ledian, Argyris Panagiotou, George Georgiou, Evagoras Aristotelous, Andreas Kouridis, Efthimios Michael, Panagiotis Ioannidis, Iakovos Iakovidis).

The 6 members who will form the Board of Administrators of the Association were elected with the result of the voting as follows:

- (a) Kondi Ledian with 55 votes
- (b) Argyris Argyrou with 57 votes
- (c) Iakovos Iakovides with 51 votes
- (d) Evagoras Aristotelous with 40 votes
- (e) George Georgiou with 55 votes
- (f) Efthimios Michael with 35 votes.

The 6 elected members then met in their own meeting, where, by unanimous decision, the tasks were assigned among the members of the Board of Administrators, as follows:

- (a) Chairman: Argyris Argyrou
- (b) Vice president: Condi Ledian
- (c) Secretary: Iakovos Iakovides
- (d) Treasurer: George Georgiou
- (e) Member A: Evagoras Aristotelous
- (f) Member B: Efthimios Michael

b. Changes to the provisions of the articles of association

- i. The current board's term is changing from one year to two.  
**(Over:37 /Con:2)**
- ii. Members who have been registered for one or more consecutive years in the association, before the general meeting, have the right to declare their candidacy for the board of the association **(Over:31 /Under:2)**.
- iii. Members who have registered/renewed their membership one month before the election meeting have the right to vote in the union's election process **(Over:29 /Under:2)**

The provisions of the statute were unanimously accepted by all members of the Association. Any modification of the articles of association may occur after the registration and following a decision of the first general assembly.

Also, it was decided among the members that the union's digital archive should be under the jurisdiction of the respective Board of Administrators and not under the jurisdiction of an individual **(Over:31 /Con:0)**.

c. The actions taken were discussed regarding the legalization of Airsoft in Cyprus, questions were answered, clarifications were given and opinions were heard from all the members of our association present on the matter.






**Figure 2:** Photo excerpt from the video presented about the social activities of the association.


**Figure 4:** Photo excerpt from the video presented about the social activities of the association.




**Figure 5:** Photo excerpt from the video presented about the social activities of the association.




**Figure 6:** Photo excerpt from the video presented about the social activities of the association.
