

## PERSONAL DATA PROCESSING NOTICE



Based on Regulation (EU) 2016/679 of the European Parliament on the Protection of Personal Data, free, specific, explicit, and fully informed consent is given to the Cyprus Airsoft Association for the processing of personal data for the purpose of:

- Receiving updates on matters such as events and/or activities of the Cyprus Airsoft Association, as well as other announcements or informational materials of the Association.

Updates will be provided via SMS messages, email, or phone calls to the contact number I specify. The processing of personal data will be carried out through collection and storage in an electronic or non-electronic file.

I have been informed and understand that:

1. The data controller is the Board of Directors of the Association..
2. My personal data (surname, first name, ID number, age, postal address, email address, mobile phone number) are recorded exclusively for the needs of the Association, and the processing is carried out by the Board of Directors of the Association.
3. The Association is committed not to transfer or disclose personal data to any third party without my prior notice and/or consent, always within the scope of its lawful activities and/or to comply with a legal obligation
4. The processing of data by the Association will continue for as long as required by the purpose of the processing, until the withdrawal of my consent. Upon withdrawal of my consent, my data will be deleted
5. I have also been informed about my right to exercise the following rights:
  - The right to access my personal data that the Association holds, possesses, and processes.
  - The right to correct or update any inaccuracies regarding my personal data (e.g., change of postal or email address, or phone number).
  - The right to delete my data from the mailing list, provided the consent is withdrawn through a written request to the Association.
  - The right to data portability.
  - The right to restrict processing.

All requests related to the above rights will be reviewed in a timely manner, in accordance with applicable laws and regulations

## DISCLAIMER OF LIABILITY AND STATEMENT OF RISK ASSUMPTION

### PLEASE READ CAREFULLY

We kindly ask you to read this document carefully, as by signing it, you waive certain legal rights. If you have any questions, we recommend consulting a lawyer before signing the form. Please fill in the blanks using capital letters and initial each paragraph before writing your name at the end of the statement.

The undersigned, \_\_\_\_\_ (full name in capital letters) with ID No. \_\_\_\_\_, hereby declare that I am aware of the potential risks involved in the activities of the sport of airsoft.

I understand that airsoft may involve inherent risks, including but not limited to injuries, loss of consciousness, cardiac arrest, etc., which may result in partial/total disability or even death. Nevertheless, I choose to participate in airsoft activities at my own risk, despite the increased danger to myself.

I commit to wearing all necessary personal protective equipment, including mandatory ballistic goggles/mask for eye protection, as well as any other protective gear I deem necessary, such as a face mask, appropriate clothing/footwear, gloves, knee pads, elbow pads, protective helmet, etc. All equipment must meet the appropriate safety standards for the purpose of the game and participation in organized fields. The Cyprus Airsoft Association recommends the use of all the above-mentioned personal protective equipment and mandates the use of ballistic goggles.

I commit to refraining from reckless actions against other participants that could endanger their safety in any way. I will not use my equipment at engagement distances shorter than the recommended distance, as specified by the rules of each event, nor will I use equipment that is not suitable for this purpose.

I understand and agree that neither the Cyprus Airsoft Association, nor the organizer, nor the municipal authority, nor any individual or entity whose facilities may be used for the events, nor the event sponsors, nor any other potentially involved party, employee, or volunteer (hereinafter referred to as the "Released Parties") can be held liable in any way for injury, death, or other damages that may occur to myself, my family, my heirs, or my authorized representatives as a result of my participation in airsoft activities or due to the negligence of any party, including the Released Parties, whether directly or indirectly.

As I am permitted to participate in airsoft activities, I hereby assume full responsibility for all risks associated with this activity, as well as for any harm or damage that my participation in the aforementioned activity may cause to third parties, including all foreseeable and unforeseeable risks related to it.

I declare that neither I, nor my family, nor my heirs or authorized representatives have any right to claim compensation from the Released Parties and will not take legal action against the Released Parties as a result of my participation in airsoft activities.

I understand that every airsoft activity is physically demanding, and I explicitly assume the risk of any potential injuries. I also declare that I do not consider the Released Parties responsible for anything that may happen during the activity, e.g., heart attack, partial/total disability, or any other form of injury or death not explicitly mentioned in this document.

I understand that I am responsible for the equipment and its specifications that I will use during the activity, and I commit to keeping it in excellent working condition, regardless of the source/supplier of my equipment.

I understand that all the terms of this document have a contractual nature and are not simply a description or justification, and that signing this document is done of my own free will. In this way, I waive any legal right to file a lawsuit as a result of my involvement in airsoft activities.

I declare that I am an adult over 18 years of age and legally competent to sign this waiver statement. The intention of the Cyprus Airsoft Association is to release all Released Parties, as defined herein, from any form of liability for bodily injury, material damage, or death, regardless of the cause (the causes include, but are not limited to, negligence of the Released Parties, whether direct or indirect).
